Enhanced Regulatory Outreach Program Process

The Maricopa County Board of Supervisors adopted a county-wide <u>Enhanced Regulatory Outreach Program (EROP) policy</u> in an effort to promote consistency and transparency among regulatory departments during the rule making process. This comprehensive process allows multiple opportunities for stakeholder input regarding the amendment and adoption of all regulatory requirements. Stakeholders can follow proposed rules throughout the process and are encouraged to provide comments at any given time during the process. Stakeholders are also encouraged to sign up to receive notifications about upcoming meetings and may submit a complaint if the department fails to observe the written procedures outlined in the policy.

 - Includes procedure for utilizing emission credits

• AQ-2017-012-Rule 314 (Open Outdoor Fires And Indoor Fireplaces at Commercial and Institutional Establishments) limits the emissions of air contaminants produced from open burning and from indoor fireplaces at commercial and institutional establishments.

- AQ-2013-001-Rule 316 (Nonmetallic Mineral Processing) limits the emissions of particulate matter from nonmetallic mineral processing plants and rock product processing plants.

- Board of Health approved for expedited process rulemaking on February 2, 2018

- AQ-2016-004-Rule 320 (Odors And Gaseous Air Contaminants) limits the emissions of odors and other gaseous air contaminants into the atmosphere.
- Workshop conducted on November 16, 2017
- Board of Health approved to initiate regulatory change on February 2, 2018
- Notice of Proposed Rulemaking published in the Arizona Administrative Register on February 23, 2018
- Oral Proceeding scheduled April 4, 2018



Municipal Solid Waste (MSW) Landfills Emission Guidelines








Recodification Project

- To rescind/remove one- and two-digit rules from the Arizona State Implementation Plan (SIP)
- Replace (if necessary) with current three-digit rules
- One- and two-digit rules in the SIP since the 1970s
- Second Phase- three-digit to three-digit rules
